CORPORATE SITE LICENSE AGREEMENT

NOTICE TO CUSTOMER

Please carefully read this corporate site license agreement before purchasing or downloading or using the product. CORPORATE SITE LICENSE GRANT

Blackblot ("Author") grants to the Customer ("Customer") a nonexclusive and nontransferable Corporate Site License ("License") to solely use the Blackblot Product Manager's Toolkit™ product ("Product"), by the Customer's Authorized Users and Temporary Authorized Users at the Customer's Corporate Site.

- *"Corporate Site": Any facilities governed by Customer.
- *"Authorized Users": All full-time or part-time employees who work on-site for the Customer at the Corporate Site.
- *"Temporary Authorized Users": All contractors and consultants who work on-site for the Customer at the Corporate Site.

All Temporary Authorized Users may also use the Product in connection with the operation of the business of the Customer. Any copies of the Product used by Temporary Authorized Users must be removed from such individual's possession once they cease working for the Customer.

EXCEPT AS EXPRESSLY AUTHORIZED ABOVE, CUSTOMER SHALL NOT: COPY, IN WHOLE OR IN PART, THE PRODUCT OR ITS DOCUMENTATION; MODIFY THE PRODUCT OR ANY PORTION OF THE PRODUCT FOR THE PURPOSE OF RESALE; OR RENT, LEASE, DISTRIBUTE, SELL, OR CREATE DERIVATIVE WORKS OF THE PRODUCT FOR THE PURPOSE OF RESALE.

The Customer agrees that aspects of the licensed materials, including the specific design and structure of individual documents, constitute trade secrets and/or copyrighted material of the Author.
